## NCAA® SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The NCAA® Be There For It All Sweepstakes (the "Sweepstakes") begins on or about 12:01 a.m. Central Time ("CT") on February 1, 2018 and ends at 11:59 p.m. CT, on March 5, 2018 ("Sweepstakes Period").
