

# SEASON TO SCORE SWEEPSTAKES

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

The **Season to Score Sweepstakes** (the "Sweepstakes") begins on or about 12:01 a.m. Central Time ("CT") on October 20, 2017 and ends at 11:59 p.m. CT, on December 1, 2017 ("Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes is open only to legal residents of the 50 United States or the District of Columbia, who are the age of majority under applicable law (but at least 18), at the start of the Sweepstakes Period, and are a member of the Buffalo Wild Wings® Blazin' Rewards® program ("Program"). Employees, directors and officers of Buffalo Wild Wings, Inc. (the "Sponsor"), and/or its affiliated entities, as well as employees, directors and officers of Sponsor's franchisees, and any of their respective affiliates, parent companies, subsidiary companies, and advertising and promotion agencies (collectively the "Sweepstakes Entities") and members of those employees' respective immediate families (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside), and/or those living in the same household of each are not eligible to participate or win.

**HOW TO ENTER:** During the Sweepstakes Period, log into your Blazin' Rewards account via the free Blazin' Rewards Mobile App (you must have a Wi-Fi enabled mobile device capable of downloading apps for this method of entry) and click on Enter to Win for the Season to Score Sweepstakes to get your free entry into the Sweepstakes. Members may also redeem 50 points for additional entries by clicking on Enter to Win. If you do not have the Blazin' Rewards Mobile App, you may visit <https://www.blazinrewards.com>, enter your mobile phone number and click "Text me the App" or visit the App Store or Google Store to download the Blazin' Rewards free app. Message and data rates may apply. Text messaging and wireless services are not available in all areas. Text STOP to stop and HELP for help. Limited to 100 additional entries. You may only use the bonus point redemption method of entry to the extent your Blazin' Rewards account contains sufficient points to complete that redemption at the time of entry. Entries exceeding the maximum number of allowable entries will not be considered and will be deemed ineligible and invalid. Please note that entries using bonus points that are deemed invalid or ineligible, or otherwise in violation of this provision, may not result in a return of points to your Blazin' Rewards account. All Blazin' Rewards entries must be received by 11:59 p.m. CT, on December 1, 2017 to be eligible for the drawing. To enter the Sweepstakes without submitting through Blazin' Rewards, send a 3x5 index card with your hand-printed name, address, telephone number and email address legibly hand-printed, to Season to Score Sweepstakes, PO Box

5020, Freeburg, IL 62243-5020. All mail-in entries must be postmarked no later than December 1, 2017 and received by December 20, 2017. Limited one mail-in entry per envelope and limited up to 100 mail-in entries. All other rules apply to a "mail-in" entry. Sponsor's time clock will be the official time clock of the Sweepstakes. Received entries become the exclusive property of the Sponsor and will not be acknowledged or returned, and no correspondence will be entered into.

**DRAWING:** On or about December 22, 2017, judges designated by the Sponsor will select the winners in a random drawing from among all eligible entries received during the Sweepstakes Period. Limit one Sweepstakes Prize per person/per Blazin' Rewards account.

**CLAIMING PRIZE:** Winners are responsible for any cost, taxes or other expense associated with a prize not specifically covered herein. Subject to verification by Sponsor. Sponsor will attempt to email Eligibility, Waiver of Liability and Publicity Release Forms ("Forms") to potential winners using the email address in their Blazin' Rewards profile ("Form Distribution"). **DISPUTE RESOLUTION/CHOICE OF LAW:** All decisions of the Sponsor with regard to this Sweepstakes are final.
